1. A certified copy of the party constitution (as lodged, accepted and approved by the Registrar of Association).
2. Certificate of Incorporation issued under the Associations Incorporation Act (Chapter 142).
3. Statutory Declaration by Members of Parliament, who are members of the party, to the effect that they are members and are not members of any other political party.
4. Statutory Declaration by the Public Officer to the effect that:
 - No non-citizens are members of the party; and
 - No non-citizens are in the employ of the party or have been engaged, whether for gain or otherwise, to assist in any way in its campaign or work.
5. Certified copy of the balance sheets and financial statements detailing assets and liabilities and income and sources of income.
6. Copy of annual income tax return for the preceding year (if any) certified by the Internal Revenue Commission to be true and accurate.
7. A list of the names, addresses and occupations of the Vice President, Deputy President or Assistant President, Assistant Secretary (known by whatever name) and Assistant Treasurer.
8. A list of branch offices and affiliates (if any) including province, physical location and postal address for each.
9. Certified copy of the balance sheets and financial statements detailing assets and liabilities and income and sources of income.
10. Copy of annual income tax return for the preceding year (if any) certified by the Internal Revenue Commission to be true and accurate.
11. A list of the names, address and occupations of the Vice President, Deputy President or Assistant President, assistant Secretary (known by whatever name) and assistant Treasurer.
12. A list of branch offices and affiliates (if any) including province, physical location and postal address for each.
